### **Enroll in TSA Pre✓® at Silicon Valley's Airport**

*-- TSA Enrollment Center to Open Sept. 11-15, 2017,  
in Terminal B Baggage Claim --*

**San José, Calif.** – The Transportation Security Administration (TSA) will open a temporary Precheck® enrollment center at Mineta San Jose International Airport (SJC) from Sept. 11 to Sept. 15, 2017, 9 a.m. – 5 p.m., in the Terminal B bag claim area (pre-security).

Precheck is the TSA's trusted traveler program which lets eligible, low-risk travelers, enjoy expedited security screening at more than 200 participating U.S. airports on [37 domestic and international airlines](#). With a 5-year, \$85 membership, travelers can speed through security and don't need to remove shoes, laptops, liquids, belts and light jackets.

Travelers seeking additional convenience while departing SJC and other U.S. airports may submit an online application in five minutes at [tsa.gov/precheck](http://tsa.gov/precheck) and schedule a 10-minute appointment for the TSA Precheck® enrollment center at SJC the week of Sept. 11.

At the appointment, applicants will complete the application in person with fingerprints, share required documentation, and pay the \$85 fee.

TSA continues to incorporate random and unpredictable security measures throughout U.S. airports and no individual will be guaranteed expedited screening.
