Assistant Director of Aviation, Judy Ross, provided a summary of passenger traffic, which remains below pre-pandemic levels. Concessions continue to experience staffing shortages. Airport opened the Zoom Zone on October 27, 2021 in collaboration with the Children's Discovery Museum. New parking system in collaboration with SP Plus. Airport also implementing a parking reservation system. Alaska Airlines is now offering a self-tag bag system. ARFF Station construction is nearing completion, with expected opening in mid-January.

Councilmember Cohen provided a Council update on the Guadalupe Gardens. Council also approved an item to help the concession businesses address the challenges posed by the pandemic.

## a. Guadalupe Gardens Update

Matthew Kazmierczak provided the Commission with a presentation about the current status on the unauthorized homeless encampment located in Guadalupe Gardens and City efforts to clear the area in humane manner, including recent Council activity. The Commission asked staff follow up questions about efforts to prevent re-encampment. Councilmember Cohen provided a summary of the thought process behind the recent Council action on Guadalupe Gardens.

#### b. Electronic Billboards Report

Matthew Kazmierczak, Rebekah Bray, and Ryan Sheelen provided a report to the Commission on the elements of proposed electronic billboards, the terms and conditions of the agreement, Council Policy 6-4, the results of the Environmental Impact Report (EIR), and the proposed

resolution to the City Council requesting approval of the EIR Addendum and to hold a public hearing. The Commission heard public comments from Jason Hemp and Les Levitt. The Commission discussed the City's policies and procedures that allowed these billboards to advance, the business model of the billboards, the indemnification and insurance elements, and the potential for other billboards throughout San José.

Action: Motion to reject the staff report. Upon motion by Vice Chair Pyle, seconded by Commissioner Head, the motion passed (7-2-0 absent).

# c. Capital Projects Update

Drew Niemeyer, Deputy Director of Planning and Development, presented a report on the following capital projects: economy lot parking garage, ARFF building, southwest quadrant apron and general aviation run-up area, runway incursion mitigation, ADA phase 1 roadways and parking, and the new facilities building.
