Air Carrier: a commercial carrier utilizing aircraft as a means of transport of passenger or freight.

General Aviation: all flights other than scheduled Air Carrier service

Capital Projects Updates




Taxiway V Phase 1A



- Project Scope: Construction of approximately 1,100 LF of new Taxiway V pavement and a taxiway connector stub of approximately 457 LF. Demolition of existing pavement, installation of drainage improvements, and associated signage and lighting.
- Completed work: underground, lime treated subgrade, base course paving
- Upcoming work: mainline concrete paving, asphalt shoulder paving, electrical
- Project completion expected by December 18, 2023




Taxiway V Phase 1B/1C



- Project Scope: Construction of approximately 164 LF of new concrete pavement, approximately 250 LF of new Taxiway V5 concrete pavement. Demolition of existing pavement, installation of drainage improvements, and associated signage and lighting
- Project will be awarded to Graniterock construction company in September 2023
- Start of construction expected by January 2024
- Grant for Phase 1B approved waiting on receipt from FAA



Aircraft Waste Disposal and Fuel Station Relocation



- Project Scope: relocate the current fuel station and aircraft waste disposal. New above ground diesel and unleaded fuel tanks will be installed for airside and landside services.
- Project will be out to bid in late August 2023 with bids opening in late September 2023
- Start of construction expected by January 2024 and substantial completion anticipated by June 2024




TSA Magazine Relocation



- Project Scope: Relocate the TSA Magazines used for training canine crews to southern end of Economy Lot 1
- Construction ongoing with substantial completion anticipated by December 2023



TSA Perimeter Enhancements (Perimeter Protection Project)





Civil scope underway at vehicle gate 252 in preparation of the installation of the hardened vehicle gate

- Project Scope: Replacement of existing chain link vehicle gates with new mechanical bi-folding vehicle gates and installation of new security sensors/technologies for an increase in perimeter coverage.
- Construction started June 2023
- Substantial completion anticipated by December 2023



Belly Freight Facility and Receiving Center Project



Preliminary site plan for construction of the New Belly Freight Facility and Receiving Center footprint and the associated buildings to be demolished

- Project Scope: Develop, program, design, construct, and commission the New Belly Freight Facility and Receiving Center facility.
- Project utilizing design-build methodology
- Request for Qualifications (RFQ) advertisement early October 2023
- Request for Proposals (RFP) released to qualified designbuild contractors in early 2024

- Project Scope: The new Facilities Division site will host two (2) building structures, an Administration and Shops Building and a Fleet Maintenance Building
- Notice to proceed issued to design-builder on May 3, 2023, to start the design process.
- Construction started June 15, 2023
- Project scheduled to be completed on June 14, 2024

Police Department Hangar





- Project Scope: Construction of a single story 7,500 sf building with one Hangar area for helicopter use and a bid alternate for a second 3,500 sf hangar for fixed wing aircraft.
- Project is currently out for bid with a bid award date of September 19, 2023
- Start of construction scheduled for October 2023
- Project scheduled to be completed December 2024



ADA Projects

Phase 1: Parking & Roadways



- Project Scope: Correct accessibility (ADA) deficiencies along roadways and parking lots/garages.
- Completion scheduled for August 22, 2023.

Phase 3A: Terminal Buildings



- Project Scope: Correct accessibility (ADA) deficiencies in Terminals.
- Construction completion scheduled for August 22, 2023.



Improvements being made:


- Staggering construction to open locations while constructing others


